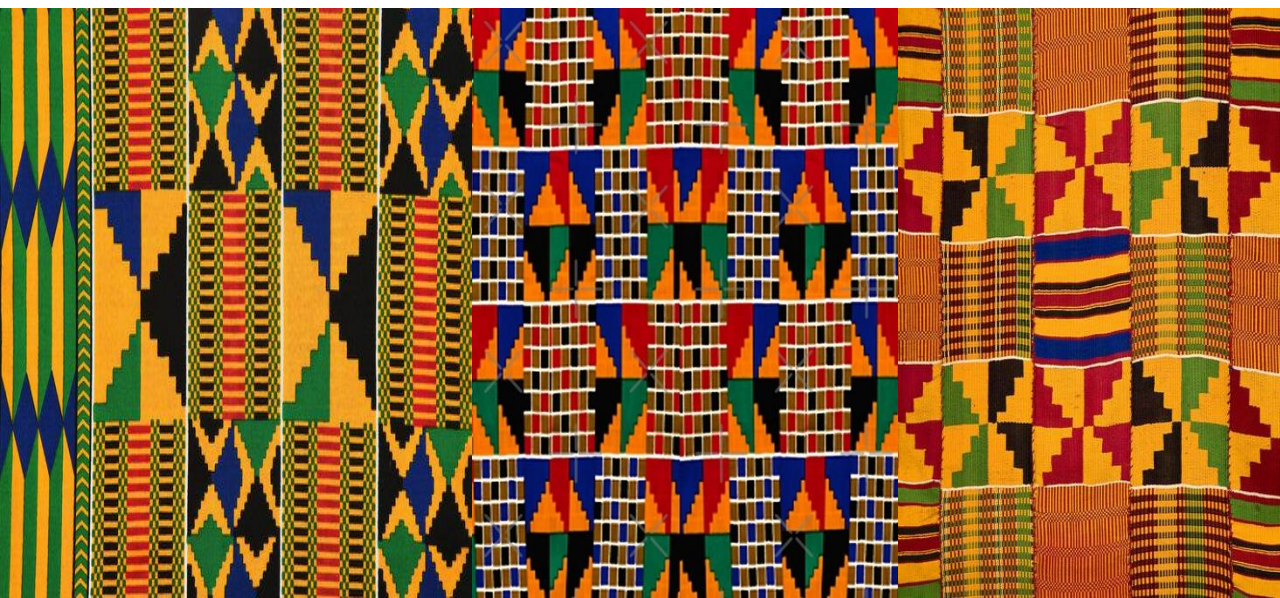

Chapter 6: Guiding Principles of Ghana CATS Implementation

The following guiding principles are an initial draft for discussion, review and further elaboration:

1. Principle 1: CATS should be formulated with a view to promoting learner mobility across sectors, levels and types of qualifications by eliminating duplication of learning.
2. Principle 2: Systems and procedures developed in institutions to support CAT should be transparent, fair, flexible and easy to use.
3. Principle 3: Decisions regarding credit transfer should be timely, academically defensible and equitable, and based on learning outcomes.
4. Principle 4: Credit awarded in recognition of prior non-formal and informal learning is of equal standing to credit awarded through other forms of learning

5. Principle 5: In line with the concept of institutional autonomy, CAT shall not affect the authority of a receiving institution to make decisions about the admission of learners. There is a distinction between the separate processes of admission and credit transfer.
6. Principle 6: Credit recognition and credit transfer should not undermine the academic rigour or integrity of the qualification into which the learner is accepted.
7. Principle 7: Institutional commitment and cooperation must be adhered to for the optimal functionality of CATS.
8. Principle 8: CATS and procedures should be subject to rigorous quality assurance measures.
