

WHAT IS AN ACADEMIC QUALIFICATION?

- ■It refers to certifications awarded upon successful completion of a course of study in higher education at various levels, including Bachelor's, Master's, and Doctorate.
- ■It is also a quality, ability or accomplishment that makes a person suitable for a particular position or task

WHAT IS AN ACADEMIC QUALIFICATION?

■ A qualification is any award which represents an attainment, following robust assessment processes, of a coherent cluster of specified learning outcomes to prescribed standards of performance.

QUALITY ASSURANCE OF QUALIFICATIONS

- ■A quality assured qualification is one that is awarded based on a set of processes and procedures to ensure that students are issued a fair grade based on their performance
- ■Regular Reviews of the qualification components to meet the contemporary context

QUALITY ASSURANCE OF QUALIFICATIONS

- Checking global trends and adjusting national, regional and continental QFs is an extremely important part of quality assurance that ensures and assures us of seamless mobility of staff and students because of comparable qualifications
- ■Safe keeping of transcripts and certificates from natural and man-made disasters-forced migration (war), fire, floods, earthquakes


































QUALITY ASSURANCE OF QUALIFICATIONS OCCURS AT VARIOUS STAGES

- 1) Formulation and designing of a Qualifications Framework plus level descriptors
- 2) Programme design
- 3) Implementation (Teaching, Learning, Assessment)
- 4) Awarding of a qualification Certification and Safe keeping of the certificates & transcripts

QUALITY ASSURANCE OF QUALIFICATIONS

■ Formulation and designing of a Qualifications Framework (QF) where the level descriptors clearly spell out the i) knowledge to be acquired ii) core, functional & essential skills, including soft skills.

The intended learning outcomes (ILO) and the required competencies are also spelt out here to match the nature of the job that the graduate will do.

QUALITY ASSURANCE OF QUALIFICATIONS FRAMEWORKS

South Africa's NQF Implementation Framework 2015-2020 has 6 Priority areas. Our focus is on

- Priority 5: Implementation of standards and quality assurance mechanisms within each of the three Sub-Frameworks
- Priority 6: Further development and improvement of the information apparatus of the NQF

REPEAL & AMENDMENTS

The South African (SA) National Qualification Framework (NQF) Act, No 67 of 2008 repealed the Qualifications Authority Act of 1995. It was amended by the i) Higher Education Laws Amendment Act 26 of 2010 iii) Higher **Education and Training Laws** Amendment Act 23 of 2012 and iii) National Qualifications Framework Amendment Act 12 of 2019

- For example, The NQF Act, No 67 of 2008 of SA has 10 learning achievement levels.
- ■The Level Descriptors which advance the objectives of the NQF, were developed by SAQA and published in the November 2011 government gazette, had input from SA's 3 Quality Councils i) Council on Higher Education, ii) General and Further Education and Training Quality Council (Umalusi) and iii) the Quality Council for Trades and Occupations)

QUALITY ASSURANCE OF QUALIFICATIONS FRAMEWORKS TEAMWORK 2nd EXAMPLE

■ The Philippine Report referenced against the ASEAN Qualifications Reference Framework (AQRF) is now aligned to the AQRF Referencing Criteria. It has been accepted and endorsed as an instrument of confidence and trust in the Philippine Education and Training System by the AQRF Committee to the ASEAN Ministers of Economy, Education and Labour.

QUALITY ASSURANCE OF QUALIFICATIONS FRAMEWORKS THE NAMIBIA EXAMPLE

■ The Namibian Qualifications Authority (NQA), is a statutory body established by Act of Parliament, "Namibia Qualification Authority Act No. 29 of 1996 to take care of the National Qualifications Framework (NQF). The NQF consists of 10 levels, each defined by a set of level descriptors.

QUALITY ASSURANCE OF QUALIFICATIONS FRAMEWORKS TEAMWORK EXAMPLE

- ■It was amended by Public Enterprises Governance Act, 2006
- ■It was also amended by the Vocational Education and Training Act, 2008

QUALITY ASSURANCE OF QUALIFICATIONS FRAMEWORKS

■ Commenced on 1 June 1998 by Commencement of the Namibia Qualifications Authority Act, 1996 and assignment of administration



QUALITY ASSURANCE OF QUALIFICATIONS FRAMEWORKS THE NIGERIA EXAMPLE

Nigeria has The National Qualifications Framework Act 67 of 2008. The Nigeria Qualifications Framework (NQF) was last revised in June 2021. It was designed to develop, classify, & recognize skills, knowledge, understanding, & competencies acquired by individuals, regardless of where and how the training or skill was acquired. It provides a clear statement of what the learner must know or be able to do, regardless of whether the learning took place in a classroom, on-the-job, or less formally. The framework also indicates the comparability of different qualifications & how one can progress from one level to another.

CHALLENGES OF QUALITY ASSURING QFs

- However, quality and quality assurance of the qualifications and qualifications frameworks are mostly comprised by
- i) splitting of the Qualifications Authorities and the Quality Assurance Bodies which causes
- ii) duplication of roles in some cases which result in iii) conflicts to the detriment of all beneficiaries iv) grey areas v) failure to revise all documents at once vi) political interference, etc


