# **BQA Mandate**

> Botswana Qualifications Authority is a Regulatory State-Owned Enterprise under the Ministry of

Education and Skills Development.

- > The Authority was established through the Botswana Qualifications Authority Act No 24 of 2013, to:
- **1.** Provide for and maintain a National Credit and Qualifications Framework.
  - National Credit and Qualifications Framework means an instrument developed for the classification of qualifications according to a set of criteria, for specified levels of learning achieved. (Botswana Qualifications Authority Act, 2013).
- 2. Coordinate the education, training, and skills development quality assurance system for General

Education (GE), Technical and Vocational Education and Training (TVET), and Higher Education



### **BQA Services**

The Authority offers the following services:

- i. Registration and Accreditation of Education and Training Providers
- ii. Registration and Accreditation of Awarding Bodies
- iii. Registration and Accreditation of Assessors and Moderators
- iv. Registration of Qualifications and Part Qualifications
- v. Accreditation of Learning Programmes
- vi. Evaluation of Qualifications
- vii. Monitoring and Auditing of Registered and Accredited Education and Training Providers





- General Education 0


# Higher Education accounts for the majority of 'SUBFRAMEWORK'.







## NCQF RELATED DEVELOPMENTS

- Review of the Legislation (BQA Act and Regulations) guiding NCQF Implementation.
- Development of some outstanding critical NCQF instruments to implement other aspects/features of the NCQF.
- Policies on Recognition of Prior Learning (RPL) and Credit Accumulation and Transfer (CAT) awaiting approval by Ministry.
- Re-engineering of and Automation of processes for efficiency.
- Formalising relationships with Regulatory and Professional Bodies through MoUs.
- Organisational Review to bring efficiency and effectiveness.
